

Terms and Conditions for the Strouds Traeger Giveaway Competition

1. Introduction

These terms and conditions ("Terms") govern the Strouds Traeger Giveaway Competition ("Competition") organised by Strouds ("Organiser"). By participating in this Competition, each participant ("Participant") agrees to be bound by these Terms.

2. Eligibility

The Competition is open to residents of New Zealand who are 18 years of age or older at the time of entry. Employees, officers and directors of Strouds, its affiliates, subsidiaries, advertising and promotion agencies and their immediate family members are not eligible to participate.
